2. A completed copy of the appropriate Affidavit form. The checklist will help you determine which of the three forms is appropriate for you.
3. A legible copy of at least one form of Secure and Verifiable Documentation (as described on the Checklist for Verification of Lawful Presence within the United States).

A copy of the forms is attached for your use. Please contact our office if you have any questions regarding these forms. We suggest that you make an extra personal copy of these documents for your records. We will not be able to provide a personal copy for your records at the course.
